#### **POSITION OBJECTIVE**

The importance of Aboriginal community and cultural inclusiveness is to be in the forefront of decision making in the daily operations of the organisation.

The incumbent must ensure the CHAC (Circular Head Aboriginal Corporation) values, vision and mission is imbedded throughout the day to day activities and is promoted to the community.

#### **POSITION SUMMARY**

This role is to be performed primarily as a Support Worker who provides a gardening and home maintenance support service for Aged Care customers in their home and immediate environment. Occasional customer transports will be required. This portion may be required, with seasonal fluctuation, up to 30 hours per week.

Secondly the general maintenance portion of the role includes assisting General Manager with Property inspections, Workplace Health & Safety inspections, and general fix it works which may be up to 8 hours per week.

#### LEVEL OF RESPONSIBILITY

A Support Worker is responsible for planning their time to ensure the tasks and activities scheduled to be performed for each customer are completed in a prompt and professional manner, in the allocated time.

This person is expected to use some initiative and originality in their approach to decision making and problem solving, using previously established work practices and procedures as a guide.

They are responsible for the quality of their own work subject to general supervision.

Can assist in the provision of on-the-job training within their level of competency and training.

#### **SUPERVISION**

A Support Worker at this level works under general direction of the Home Care Coordinator within defined work practices and procedures and General Manager in regard to CHAC scheduled and adhoc maintenance.

#### **ROLES AND RESPONSIBILITIES**

A Support Worker will be responsible for, but not limited to, the following key tasks and duties:

- Provide gardening services to clients in their own homes such as mowing, hedge trimming, pruning, hazard removal, moss clearing, pressure washing, weed spraying and brush cutting.
- Provide home maintenance services to clients in their own homes such as changing tap washers and light bulbs;
- Report any equipment maintenance, hazards or work health and safety incidents as identified to supervisor;
- Ensure correct safety and risk practices and protocols are being observed and personally adhered to such as use and care of Personal Protective Equipment (PPE), the labelling, storage and use of chemicals and manual handling/lifting techniques are used;
- Ensure client, staff and privileged CHAC information remains confidential and secure at all times;
- Perform property inspections in accordance with CHAC provided protocols under General Manager direction;
- Perform general maintenance in a safe manner such as gardening, painting, repairing and supervising external contractors where directed and within competency levels.

#### PERFORMANCE TARGETS AND INDICATORS

Performance targets and indicators are included in the performance appraisal, which will be reviewed and amended annually, or more frequently as required.

#### QUALIFICATIONS, SKILLS AND EXPERIENCE

- Qualifications would be preferred but not essential

- Current Level 2 First Aid Certificate;
- Provide a satisfactory National Police Check and Working with Vulnerable people check;
- Can competently undertake risk assessments prior to commencing any work within scope;
- Currency in Working at heights if required to work at heights.
- Can clearly understand Workplace Health and Safety regulations, policies and procedures as they apply to the workplace and a given task including Lock out Tag out requirements.

#### **SELECTION CRITERIA**
